

2010 USA LEAGUES - NORTHERN COLORADO

Ages: 18 years of age or older (Seniors 50 and over) (Super Seniors 60 and over)

Levels: Men and Women divisions from 2.5 through 5.5

Scoring: Regular scoring, 2 out of 3 sets, 7 point tie-break to determine set winner.
2.5, 5.0 & 5.5 plays 2 doubles & 1 singles match
May use 3rd-set tie-breaker in ALL leagues (if everyone agrees)

- Districts, Sectionals, Nationals and Super Senior League - 10 point tie break in lieu of third set!

Fees: Players must pay USTA and TAG membership in addition to all league fees.

Dates: See 2010 Northern Colorado League Menus on-line

INFORMATION FOR YOUR TEAM MEETING

Roster: The roster sheet is on line it is designed to help you the captain organize your information, and to provide information for the league coordinator.

USTA Dues: Players USTA membership **MUST** be valid through the month of the District competition for that league **IN ORDER FOR THE CAPTAIN TO REGISTER THE TEAM**. Any player whose membership is found to be invalid through the entire league season will have all matches previously played automatically reversed.
ALL players must be a USTA member. Individuals should renew or apply for a USTA Membership by the Internet at www.usta.com (Select tennis link and than membership) or phone 1-800-990-8782
Do not renew by mail -- the process takes too long and your team members may not be renewed in time for the team registration.

League Fees: All players must pay the league fees shown on the League Menu. In addition each player will be charged a \$3.00 on-line registration fee for maintaining the website. This charge will show as a separate user fee charge on the captain's charge card and is not refundable.

TAG Fees: All players must be a member of a local tennis association to play on a USA team. Dues for the Tennis Association of Greeley are \$12 for a single membership and \$18 for a family membership. Everyone **MUST** pay TAG dues this year. There is **NO** reciprocity.

In order to receive your team number, which is necessary to register your team, Waneta, Peggy, or Julie will need the following:

- ① Completed roster sheet - on line submit to appropriate coordinator
- ② Every member of the team **MUST** be a member of the local association.
- ③ The name of the courts where you will host your home matches. You need to make these arrangements. Your coordinator will **NOT** do this for you.

All **Adult League Captains** should put this information in their envelopes and return to Waneta Elliott. The deadline is **February 26 12:00 PM**. You may mail to W. Elliott, 1859 24 Avenue Court, Greeley, CO 80634 or send the roster electronically. The **DEADLINE** is a **RECEIVED** deadline not a postmarked deadline. Waneta will submit the information to the Northern League Coordinator and she will assign team numbers. Waneta will notify captains when the team number is available.

All **other League Captains** should get their completed information to Peggy, Renae or Barb at least **seven** days before the registration deadline for that particular league. Check the 2010 Northern Colorado League menu for registration deadlines.
